Code of Conduct

(for Grades 6 and Higher)

The following Code of Conduct applies to students while attending the physical school, and/or while online using district network services.

Purpose:

We, the students and staff at Home Learners' Program, are committed to promoting a safe learning environment that respects the rights of all individuals, values diversity, and is free from all forms of discrimination as per the BC Human Rights Code. In keeping with these principles and to further their aims, the purpose of this code of conduct is:

- (i) to establish and maintain appropriate balances among individual and collective rights, freedoms and responsibilities;
- (ii) to clarify and publish expectations for student behaviour while at school, and while attending any school function or activity at any location.

Acceptable Conduct:

Students will:

- (i) Demonstrate the highest standards of conduct, honesty, integrity and good judgment when involved in school sponsored activities, both in person and online.
- (ii) Be cooperative, courteous and respectful in dealings with students, school staff, teachers, administrators and school visitors.
- (iii) Respect the rights of others. Students will not take items that do not belong to them and will not threaten or interfere with other students.
- (iv) Carry out directions by school staff, teachers and administrators.
- (v) Take care of the books, equipment and learning materials provided for them.
- (vi) Use their time in an educationally appropriate manner when in attendance at the school.
- (vii) Treat the school building and grounds with care, including the prevention of litter.
- (viii) Have no contact with alcohol, drugs or weapons during the school day while at school or on the school grounds, or in attendance at any school sponsored event in the community at any time.
- (ix) Act as responsible members of the school neighbourhood, by being courteous to people living in the area, by refraining from disturbing or disrupting their daily activities and by being respectful of their property.
- (x) Comply with the Tobacco Control Act, prohibiting tobacco use (smoking) on school property.
- (xi) Fulfill all responsibilities outlined in the DL agreement as signed by all students.

Unacceptable Conduct:

Students will not:

- (i) Interfere with the learning of others.
- (ii) Interfere with a safe, orderly learning environment.

Unacceptable Conduct (Continued):

- (iii) Create unsafe conditions.
- (iv) Bully, harass or intimidate.
- (v) Use physical violence.
- (vi) Use retribution against a person who has reported incidents.
- (vii) Possess, use or distribute illegal or restricted substances.
- (viii) Possess or use weapons.
- (ix) Steal or damage property.
- (x) Submit other's work as their own.
- (xi) Tamper with the School District network or online courses.

Rising Expectations:

As students grow older and mature, our expectations regarding their conduct grow too. Therefore, it is expected students will understand the accountability we hold to their actions and practice self-discipline to that end.

Consequences:

The severity and frequency of unacceptable conduct as well as the age and maturity of students is considered in disciplinary action taken. In keeping with this principle:

- (i) Responses to unacceptable conduct are fair and consistent, while reflective of the particular conduct in question.
- (ii) Disciplinary action, wherever possible, is preventative and restorative, rather than merely punitive.
- (iii) Students, as often as possible, are encouraged to participate in the development of meaningful consequences for violations of the established code of conduct.

Notification

School administrators and teachers may have the responsibility to advise other parties of the serious breaches of the code of conduct to:

- (i) Parents of student offender(s) – in every instance.
- (ii) Parents of student victim(s) – in every instance.
- (iii) School district officials – as required by school district policy.
- (iv) Police and/or other agencies – as required by law.
- (v) All parents – when deemed to be important to reassure members of the school community that school officials are aware of a serious situation or incident and are taking appropriate action to address it.
